Peru: The BVL General index ended today's session with a positive result of +0.62%. The index maintains a negative cumulative annual trend of -0.07% in local currency and a negative cumulative trend of +0.26% in dollar-adjusted currency. Regarding the S&P/BVL Peru SEL, it varied by +1.04% while the S&P/BVL LIMA 25 by +0.10%. The spot PEN reached S/.3.9862. Headline: BCR: Mortgage credit grew 8.9% yoy in September.


Chile: The IPSA index ended the day with a positive return of +0.12%. The most benefited sectors of the day were Real Estate (+3.74%) and Information Technology (+2.44%). The best performing stocks were Enel Chile SA (+5.06%) and Cencosud Shopping SA (+4.99%). Headline: IMF forecasts 1.3% contraction of the Chilean economy in 2023.

Colombia: The COLCAP index ended the session with a positive return of +0.97%. The most favored sectors of the day were Materials (+1.80%) and Energy (+1.51%). The best performing stocks were Cementos Argos SA (+9.20%) and Grupo de Inversiones Suramericana (+5.56%). Headline: In September there were 2.69 million unemployed and the national unemployment rate dropped to 10.7%.

Mexico: The IPC index closed the day in positive territory +1.70%. The day's weakest sectors were Non-Basic Consumer Products (+2.50%) and Materials (+2.48%). The best performing stocks were Industrias Penoles SAB de CV (+6.94%) and Operadoras de Sites Mexicanos SA de CV (+5.69%). Headline: Mexico's GDP advanced 1% in the third quarter and has 18 consecutive months of progress.





Global Overview:

United States:

The U.S. market closed with negative returns, with Wall Street starting the week with losses as investor interest focused on the growth outlook and the Federal Reserve's monetary policy meeting. The DOW JONES index closed with losses despite gaining 14%, posting its best mark since 1976 in October. At the same time, the Fed is on track to raise interest rates by 75 bps on Wednesday for the fourth time this year with the goal of lowering the country's inflation. However, speculation of a slowdown in the pace of these rate hikes later in the year is growing around positive. The S&P500 index also ended with a negative performance, with almost all 11 sectors falling with the Technology and communication services sectors leading the losses. On the other hand, the Energy sector was the only sector in the green, thanks to President Joe Biden's comments on oil companies. Finally, the NASDAQ index ended the day with negative index, showing mixed signals about the health of the world's largest economy, with Meta, Microsoft, Amazon and Alphabet stocks reporting disappointing results. Likewise, Apple lost 1.54% after a Reuters report mentioned that production of its iPhones could fall by up to 30% next month. It is worth noting the most prominent stocks to release results this week, such as Uber, Pfizer and Advanced Micro Devices. Thus, DOW JONES -0.39%, S&P 500 -0.75% and NASDAQ -1.03% ended the day with negative results.


Europe:

Major European indices ended the session with mostly positive performances. The pan-European STOXX 600 index closed higher following economic growth of 0.7% in the second quarter; this performance was also driven by the pharma and personal care grocery sector, particularly Reckitt, Jefferies and Unilever stocks. The U.K. market, reflected in the FTSE 100, was boosted by the 1.5% reversal of the benchmark two-year swap curve's benchmark ratio for mortgage prices. In addition, house prices continue to decline, for which the 95% loan-to-value ratio is important to consider as it has an effect on the supply of mortgage loans. Similarly, the German market, reflected in the DAX index closed in positive territory due to the revaluation of monetary policy. The French market closed lower, due to the tightening of monetary policy by the ECB. In addition, the Fed is expected to raise the benchmark interest rate by 75 basis points this week. The top gainers were Ubisoft (+5.9%) which focuses on video game development and distribution, followed by Tokmanni (+3.6%), a retail chain. On the other hand, the worst performing stock was Pandora, down 1.8%. Thus, FTSE 100 +0.66%; CAC 40 -0.10%; DAX +0.08%; STOXX 600 +0.35% ended at positive levels.

Asia:

The main Asian indices closed with mixed performances. The Shanghai Composite closed with losses, after processing the manufacturing PMI downgrade due to low external demand and COVID-19 restrictions. On the other hand, this week in companies have reduced their investments to an all-time low, as controls on COVID-19 remain in place. The Hang Seng index closed in negative terms. Hong Kong's GDP declined by 4.5% in Q3 2022, while analysts were expecting a 0.7% increase. In addition, the foundations for a Chinese economic recovery are not in place. The South Korean market rose this session. At the same time, its industrial production rose by 0.8% in September, below expectations (0.9%). The Japanese market closed higher, gaining its largest gain for the month. Technology stocks led the advance with strong gains from SoftBank Group (6.2%), Bank Of Innovation (24.5%), Advantest (2.1%), among others. The Australian market ended higher, driven mostly by technology and energy stocks. However, investors are waiting for the Reserve Bank of Australia to raise its interest rate by 25 basis points to a rate of 2.85% on November 1, thereby raising exchange rates and borrowing costs. Thus, NIKKEI +1.78%; HANG SENG -1.18%; CSI 300 -0.92%; S&P/ASX 200 +1.15%; KOSPI +1.11%, SHANGHAI COMPOSITE -0.77% ended with mixed performances.




