Peru: The General Index of the BVL of Peru ended today's session with a positive result of +0.98%. The index maintains a cumulative positive annual trend of +1.79% in local currency, while the yield adjusted to foreign currency is +0.57%. Then, the S&P/BVL Peru SEL obtained a positive return of +1.15%, while the S&P/BVL LIMA 25 increased +0.36%. The spot PEN reached S/3.2769.

Chile: The IPSA index ended the day with a positive result of +0.79%. The sectors of the index with the upward results were Information Technology (+3.62%) and Industrial (+1.62%). On the other hand, the securities with the highest results were Sonda SA (+3.62%) and Lan Airlines SA (+3.19%).

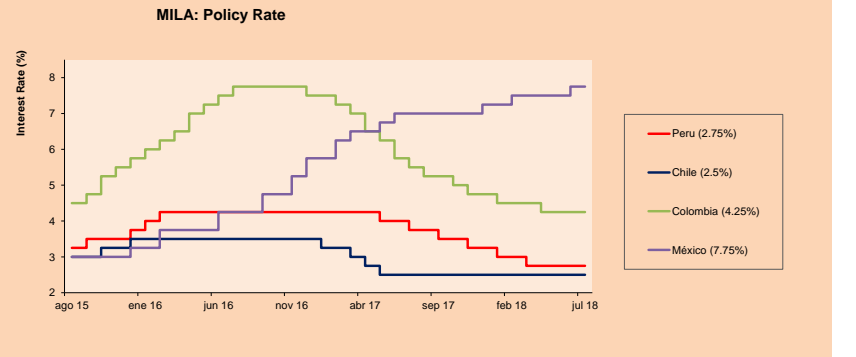
Colombia: The COLCAP index had a negative yield of -0.27%. The sectors of the index with the least favorable results were Industrial (-1.71) and Materials (-0.42%). On the other hand, the stocks with the worst results were Avianca Holdings SA (-2.24%) and Cementos Argos SA (-2.17%).

Mexico: Mexico's IPC index closed today's session with a positive result of + 1.25%. The sectors of the index that generated the highest results were Materials (+2.53%) and Industrial (+1.56%). Finally, the stocks with the highest yields were Cemex SAB de CV (+3.54%) and Grupo Aeroportuario del Sureste SAB de CV (+2.97%).

Global Overview:

United States:

The North American market closed the day on Tuesday with rising results among its main indices. The S&P500 closed positive with +0.48% and the Dow Jones did +0.79%. In business news, Amazon shares fell -2.4% after a tweet from Donald Trump where he said the company and the Washington Post newspaper were lobbying. Both companies are owned by Jeff Bezos. However, during the day it was able to recover to close positive with +1.51%. Finally, the shares of Alphabet, the owner of Google, had one of the highest yields of the day with +3.83% after posting its quarterly results above the expectations of investors. In other news, interest rates on 2-year government notes reached their maximum value since the last 10 years, paying investors a yield of +2.65%. On the other hand, tensions between the United States and Iran over oil production increased the price of Texas crude for September by +0.90% to reach \$68.52 per barrel. Recall that the conflicts are linked to the departure of the United States from Iran's nuclear program in May, hampering the oil output of the Middle East. Additionally, the American Petroleum Institute reported that US crude supplies fell by 3.16 million barrels last week.

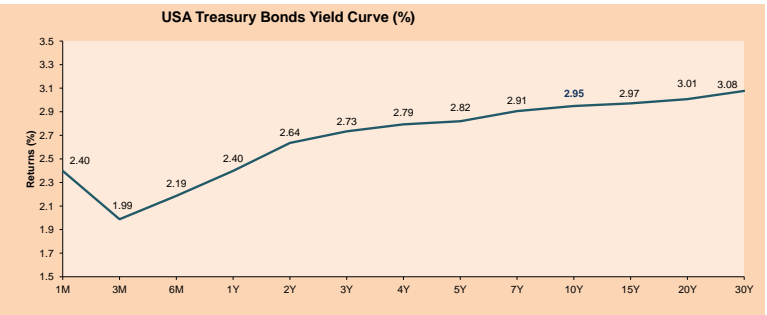
Europe:

The European stock market closed the session with positive results reaching its highest gain in more than a month, thanks to the momentum generated by the companies in the financial sector. The stock market maintained a positive round after the data on manufacturing activity in the euro area in July was higher than expected, printing 55.1 points as reported by IHS Markit. The European Stoxx 600 index rose +0.86%, driven by the basic materials and financial sector, while the German DAX index, the French CAC 40 and the Italian FTSE MIB rose +1.12%, +1.04% and +1.25% respectively. As for the euro, it went from buying \$ 1.194 to \$ 1.160 on the last Monday in New York. In business news, UPS shares rose more than 4%, marking its biggest advance since weeks, boosted by the second quarter net profit report, which increased 9.4% to 1.28 billion Swiss francs, on the other hand, Peugeot rose +14.88% after its first quarter profit reached 1,480 million euros, and Randstad's (+3.92%) rose after its adjusted net profit increased 23% in the second quarter.

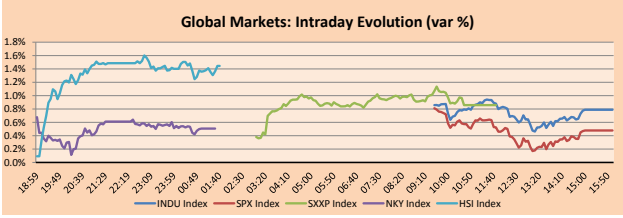
Asia:

The Asian stock market ended the day today with positive results among its main indices. Profits were led by China's benchmark index, the Hang Seng, which closed at +1.61%. This close was benefited by the prospect of more flexible policies, among which analysts noted that the new rules for the management of the assets of the institutions and in the administration of the assets of the companies have been less strict than expected and that this it would help reduce systemic risks. Also, the Chinese yuan depreciated against the US dollar, from 6.8145 to 6.8448 yuan per dollar, benefiting Chinese exporters. On the other hand, the Nikkei 225 benchmark index of Japan closed with a gain of +0.51%, partially reducing the losses obtained in the previous session of -1.3%, after the Japanese yen depreciated against the US dollar, passing from 110.75 to 111.30 yen per dollar. Also, the index was benefited by the good results of Showa Shell Sekiyu, an oil refining company, and Ono Sokki, a manufacturer of surveying equipment, after the good profit forecasts for both companies.

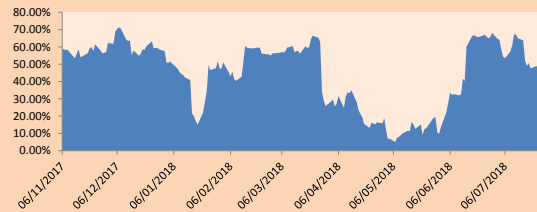

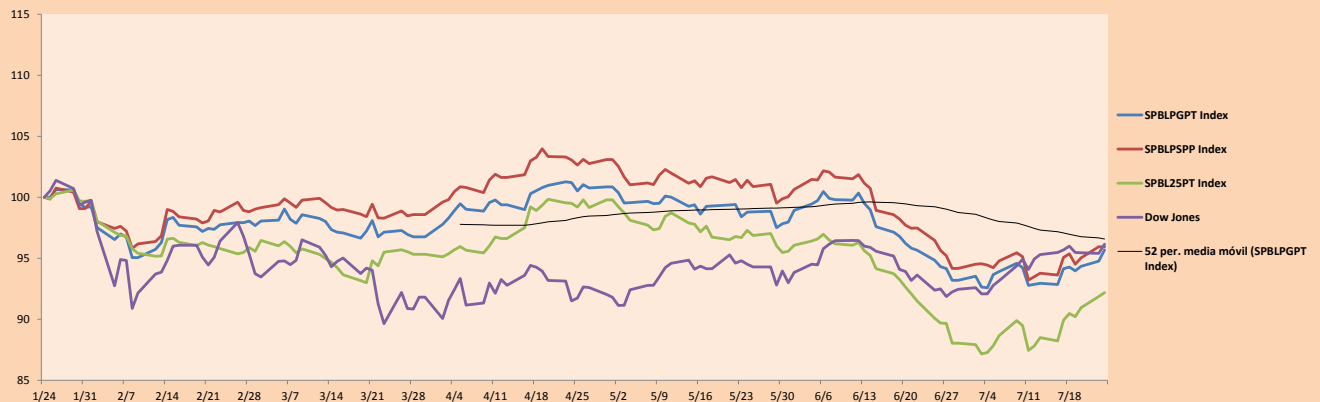
